## Adapted processes for container handling during night shifts, trial operation at the EUROGATE Container Terminal Bremerhaven from Monday, December 18, 2023

Ladies and Gentlemen

In a letter dated November 3rd, 2023, we informed you about the adjusted opening hours our Interchange / Service-Desk, for the terminals EUROGATE CTB and MSC Gate, will be adjusted as of January 2nd, 2024.

As a kind reminder, from Tuesday, January 2nd, 2024, our service desk will be open Monday to Friday between 6:00 a.m. and 10:00 p.m. and Saturdays from 6:00 a.m. to 2:00 p.m. The opening times of our truck gate remain unaffected, i.e. deliveries and pickups of containers are generally still possible during the usual opening times, from Monday 6:00 a.m. to Saturday 2:00 p.m.

**From Monday, December 18th, 2023, we invite you to take part in a trial run**, which will give you and us the opportunity to try out the following necessary adjustments.

• The delivery of OOG, empty flats and flat bundles will be possible at the self-service consoles - even without first going through the OCR video gate. The data from the prebooking of the tour plan forms the basis for this and is presented to the driver at the console for confirmation.

• Pickup of dangerous goods containers (ADR), in slots between 10 p.m. and 6 a.m., require the transport document to be submitted by 8 p.m. at the latest on the booked pickup day, in advance by email to our service desk [ <a href="mailto:cta@eurogate.eu">ctb.cta@eurogate.eu</a>] for pre-cheking. The same applies to registration certificates for tractors and trailers/semi-trailers if they are Class 1 dangerous goods or dangerous goods in tank containers. The ADR certificate of the respective driver will be checked by our gate checkers directly at the entrance for pickup. This therefore does not need to be sent to us in advance.

## The following also applies from January 2nd, 2024:

- The execution of tour plans of all kinds, in slots between 10 p.m. and 6 a.m., requires the respective driver to have a trucker card that is already authorized for Bremerhaven. The issuance of a trucker card or the authorization to use a card that has already been issued in Wilhelmshaven or Hamburg, as well as the unblocking of a trucker card that has been temporarily blocked for Bremerhaven, can only take place during the opening hours of the service desk.
- Temporary deliveries to the veterinary office or border inspection point/ "Grenzkontrollstelle" as well as to external customs inspections continue to be guaranteed during the operating hours of the corresponding inspection points between 6:00 a.m. and 10:00 p.m.
- From January 2, 2024, deliveries and pickups in land-land transport (KLV) can only take place during the opening hours of the service desk, **provided further loading is to take place within the same night shift**.
